#### 1. General

1.1. These Guidelines are for the general public and in particular persons intending to obtain permit to clear severely restricted chemicals (Pesticides, agro Chemicals and fertilizers) and chemical substances listed in schedule I, II and III of the 1997 chemical weapon convention.

1.2. These Guidelines prescribe the requirement for documentation, processing, personnel requirement, and timeline for obtaining permit to clear.

# Step I

# 1. Application

- 1.1. Application letter on company's letter headed paper addressed to the Director-General (NAFDAC), ATTENTION: Director, Chemical Evaluation & Research (CER), Isolo stating the chemicals, the quantities required (SI unit) and purpose for which the chemicals are intended. The Application must be signed by either the Managing Director/CEO, the Technical Officer or Designated Personnel of the Company.
- 1.2. The following documents should be attached to the application:
  - 1.2.1. The list of chemicals and quantities required.
  - 1.2.2. Permit to Import
  - 1.2.3. Single Goods Declaration Form (SGD)
  - 1.2.4. Bill of Lading/Airway Bill.
  - 1.2.5. Commercial Invoice
  - 1.2.6. Form M
  - 1.2.7. Packing List
  - 1.2.8. Pre-Arrival Assessment Report (PAAR)
  - 1.2.9. Certificate of Analysis/Quality Control Certification to include Name, Signature and Designation of Analyst.
  - 1.2.10. Certificate of Value and Origin.
  - 1.2.11. Valid End User Certificate issued by the Office of the National Security Adviser (where applicable). Refer to www.euc.nsa.gov.ng for List of Chemicals in this category.
  - 1.2.12. Evidence of payment for Permit to Clear

## Step II

# 2. Processing of Permit

- 2.1. Upon satisfactory documentation, the application will be processed further and permit to clear will be issued.
- 2.2. For unsatisfactory application, a Query will be issued to the company.

## **6.1 Personnel**

The company representative responsible for interfacing with the Agency should be a technical officer with scientific background (minimum of Ordinary National Diploma (OND) or its equivalent in a science related is required). The technical officer will be responsible for explaining and discussing the exact chemical nature and use of the items for which application is submitted. He is also responsible for the handling and storage of the chemicals.

## 6.2. Timeline

- 6.2.2 A processing period of forty-eight (48) work hours should be allowed from the time of submission of a complete application. Note that the timeline for processing is suspended when there is a query and resumes when applicant complies and communicate compliance to the Agency.
- 6.2. It is an offence for any company to clear severely restricted chemicals (Pesticides, agro Chemicals and fertilizers) and chemical substances listed in schedule I, II and III of the 1997 chemical weapon convention from the Port.
- 6.3. Please note that all applications for Permits to clear are to be submitted and processed manually.
