### **GUIDELINES FOR CLEARING OF IMPORTED FINISHED BULK FOOD, FOOD RAW MATERIALS AND ANIMAL FEED AT PORTS OF ENTRY IN NIGERIA**

## 1. **General**

- 1.1. These Guidelines are for the interest of the general public and in particular, importers of finished bulk food, food raw materials and animal feed into Nigeria.
- 1.2. It is necessary to emphasize that, no Animal Feed shall be manufactured, imported, exported, advertised, sold, distributed or used in Nigeria unless it has been registered in accordance with the provisions of NAFDAC Act CAP N1 (LFN) 2004, other related Legislations and the accompanying Guidelines.
- 1.3. It is also necessary to emphasize that no finished bulk food and/or food raw materials should be imported without obtaining Import Permit.

## **Step I**

### 2. **Payment**

- 2.1. The applicant is required to visit:
  - 2.1.1. E-clearance office at Ports Inspection Directorate, Yaba, Lagos State to obtain Payment Advice for the clearance of the products (applicable for applicants not online).
  - 2.1.2. [www.remita.net](http://www.remita.net) to generate Remita invoice and print out a copy of the invoice.
  - 2.1.3. Any nearest commercial bank for payment.
  - 2.1.4. NAFDAC Accounts Office to collect receipt of payment.

## **Step II**

### 3. **Submission of Documents for First Endorsement**

- 3.1. The applicant is to write an Indemnity Letter addressed to the Director-General, National Agency for Food and Drug Administration and Control (NAFDAC); ATTENTION: The Director, Ports Inspection Directorate, NAFDAC, Yaba, Lagos State. The letter should state that
  - 3.1.1. The Agency will be informed 48hrs before the arrival of the product.
  - 3.1.2. The Agency will be duly invited for examination of the consignment.
  - 3.1.3. Product will not be sold or distributed without the satisfactory pronouncement by the Agency.
- 3.2. The letter should be submitted via email ([ports@nafdac.gov.ng](mailto:ports@nafdac.gov.ng)) or at the Ports Inspection Directorate, Yaba, Lagos State [or any NAFDAC Office (outside Lagos)] and should be accompanied with the following documents:
  - 3.2.1. Valid NAFDAC Permit

- 3.2.2. Single Goods Declaration (SGD) Form
- 3.2.3. Commercial invoice
- 3.2.4. Pre-Arrival Assessment Report (PAAR)
- 3.2.5. Form M
- 3.2.6. Bill of Lading/Airway Bill
- 3.2.7. Packing List
- 3.2.8. Form C-30
- 3.2.9. Photocopy of payment advice
- 3.2.10. Evidence of current product registration with NAFDAC
- 3.2.11. Original copy of Certificate of Analysis
- 3.2.12. Original copy of Radiation Analysis Certificate (for meat & meat products, milk & milk products, fish & fish products)
- 3.2.13. Original copy of Phytosanitary Certificate (For products of plant origin)
- 3.2.14. Evidence of Health certificate (Issued and endorsed by the controlling authority in the country of origin)
- 3.2.15. Original copy of CRIA (Clean Report of Inspection and Analysis) for products coming from China.
- 3.2.16. A Letter of undertaking stating that the product(s) will be forfeited if found unsatisfactory
- 3.2.17. The address of warehouse where the product will be stored.
- 3.2.18. Evidence of payment to the Agency
- 3.2.19. Letter of introduction with a copy of identity card of company representative
- 3.2.20. Local Purchase Order from holders of Permit/Approval

### **Step III**

#### **4. First Endorsement**

- 4.1. Upon satisfactory vetting of the application and accompanying documents, the Single Declaration Goods Form (SGD) is given the First Endorsement.

### **Step IV**

#### **5. Joint Inspection of Consignment**

- 5.1. Joint Inspection of the consignment is carried out by NAFDAC and other relevant Government organizations.

## **Step V**

### **6. Second Endorsement**

- 6.1. The company representative is required to re-present all documents presented for First Endorsement. This should be accompanied with the report of the Joint Inspection and sample of product (s) in line with the Agency's applicable sampling Guideline for verification.

## **Step VI**

### **7. Release of consignment**

- 7.1. Upon satisfactory verification of the documents and product sample for the purpose of Second Endorsement, the Single Goods Declaration Form is given Second Endorsement which is the release of the consignment to the importer.

### **8. Tariff**

- 8.1. Please refer to tariff section.

### **9. Note**

- 9.1. The imported products can only be marketed and used after a satisfactory Laboratory evaluation.
- 9.2. The timelines for the various processes include;
  - 9.2.1. Cost assessment and issuance of Payment Advice is Ten (10) minutes
  - 9.2.2. Issuance of first endorsement is Thirty (30) minutes
  - 9.2.3. Physical inspection as determined by the Joint Task Force is Two (2) hours
  - 9.2.4. Issuance of second endorsement is Fifteen (15) minutes
- 9.3. Note that the timeline for processing is suspended when there is a compliance directive and resumes when applicant complies and communicates compliance to the Agency.
- 9.4. In case of unsatisfactory laboratory analysis report, the consignment is placed on Hold. This may be for destruction or for further investigation which may include retest by the Agency and/or independent laboratory.
