NAFDAC a Statutory Body

The National Agency for Food and Drug Administration and Control (NAFDAC) was established by Decree No. 15 of 1993 as amended by Decree No. 19 of 1999 and now the National Agency for Food and Drug Administration and Control Act Cap N1 Laws of the Federation of Nigeria (LFN) 2004

Mandate: To regulate and control the manufacture, importation, exportation, distribution, advertisement, sale and use of Food, Drugs, Cosmetics, Medical Devices, Packaged Water, Chemicals and Detergents (collectively known as regulated products).

Vision:

 The Vision of NAFDAC is "to be a world class regulator that ensures availability of quality and safe Food, Drugs and other regulated products."

Investigation & Enforcement Directorate is the arm of NAFDAC, principally responsible for enforcing compliance with the Agency's mandate on regulatory activities.

It also coordinates enforcement activities of all other Directorates, Zonal and States offices of NAFDAC Nationwide.

Regulatory Activities

– what are we doing?

- Nationally controlled to reduce supply and track distribution.
- Routine inspection and monitoring of facilities where medicines are stored, manufactured and distributed.
- Restrict importation of tramadol to 50mg and 100mg dosage strength.
- Estimation of licit needs 2017 and 2019.

Enforcement-Related Successes Recorded

(from Nov. 2017 till date)

- Return of NAFDAC to the ports
- Three persons involved in the distribution of banned Tramadol have been arraigned at the Federal High Court, Lagos. The Agency secured the conviction of one of the distributors and the court ordered the destruction of the seized consignment.
- Destruction of Tramadol with estimated street value of one trillion, seven hundred and two billion, six hundred and ninety-two million, two hundred and fifty thousand naira (N1,702,692,250,000.00)
- Continuous seizures and destruction of substandard and falsified medicines, unwholesome foods and beverages

Enforcement-Related Successes Recorded (from Nov. 2017 till date)

- Upgrading of NAFDAC laboratories
- Enthronement of Quality Management Systems and ISO 9001 certification
- Global Benchmarking Audit ISO 90004
- Digitalisation of NAFDAC processes

Recommendations

- Sustenance of inter-agency collaborations NAFDAC,
 Nigeria Customs Service, NDLEA, Police etc
- Sustained Enforcement of existing regulations regarding the following;
- Prohibition of importation of unregistered medicines
- Adherence to approved dosage strength
- Adherence to importation guidelines, and Procedures
 - permits to import and clear and inventory control.

Challenges of Anti-Counterfeiting

- Weak penalty One Ezeanwu Ifeanyi was sentenced to 5 years imprisonment or an option of fine of N300,000.00 for being in possession of Tramadol by the Federal High Court, Lagos.
- Weak drug distribution system
- Porous borders
- Inadequate resources (systems and manpower) for proper monitoring
- Lack of synergy for sharing information (intelligence) in real time between relevant MDAs
- Limited knowledge of consequences of the 2005 Strategic Action Against Piracy ("STRAP") initiative in counterfeiting of Intellectual Properties (Trademarks, Patents) related to regulated products.
